The College has well defined mechanism to deal with internal examination related grievances to be transparent, time -bound and efficient as given below.

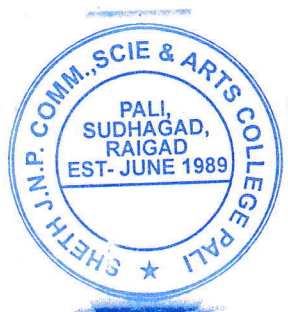
- To develop transparent mechanism the examination committee has constituted along with unfair means committee.
- Time bound and efficient

If the internal examination grievances has received from the students in writings, then the examination committee verifies it and take necessary measures in stipulated time. All process is time bound and efficient. As per the University guidelines the process has completed and the results are displaced on the notice board or conveyed to the students.

The following table reflects the nature of probable and grievances and corrections for complaints made by the students.

Process	Grievance Case	Correction mechanism
Filling of examination forms online	Discrepancies in name, selection of course, subjects and late fees.	Forward to the University to the necessary correction.
Issuing Examination numbers, Hall tickets	Discrepancies in name, course code, delay	Forward to the University for necessary action. In case of delay of issue of Hall tickets by the University, University office bearers allow to students to appear for examination to avoid academic loss of the students.
Evaluation	Revaluation, Verification of marks, Photocopy etc.	Application received in due time for revaluation of answer sheets, verification of marks and a photocopy of answer sheet is collected from the students and forwarded to the University for the necessary action.
Internal Evaluation	Issue of absentee, submission of project assignment/ Marks awarded etc.	With regard to the internal marks awarded at college level, students can approach the concerned subject teachers/HOD / Examination Committee

		immediately after the declaration of results. The college ensure the redressal of the grievance if anyone priority basis.
Miscellaneous	other minor issues	The college is having a separate grievance redressal cell and unfair means committee to help the students with regard to the any other grievance
Rare cases	Injustice/ victims of horn's effect in evaluation	In real cases, when the marks of a group of students are affected the students can approach the control of Examination of the Vice Chancellor of the University.
